Under Article XI, Section 5, of the Agreement of 19th June, 1951, between the Parties to the North Atlantic Treaty regarding the Status of their Forces, a member of a North Atlantic Treaty force or a civilian component shall be entitled, at the time of his first arrival to take up service in another North Atlantic Treaty country, or at the time of the first arrival of any dependent to join him, to import his personal effects and furniture free of duty for the term of such service.

Under Article XI, Section 6, of the same Agreement, a member of a North Atlantic Treaty force or a civilian component may, while serving in the territory of another North Atlantic Treaty country, import temporarily free of duty his private motor vehicle for the personal use of himself and his dependants.

Members of a foreign North Atlantic Treaty force stationed in Denmark will be granted the above privileges subject to the deposit, at the customs office for the place of entry, of a declaration in the present form, duly filled in and signed by the owner of the property in question and certified by the COMMANDER HEADQUARTERS SUPPORT GROUP, JHQ NORTHEAST, 7470 KARUP J.

The goods may not normally be disposed of within Danish territory by way of either sale or gift. In particular cases, however, such disposal may be authorised on conditions imposed by the customs authorities and the Danish Board of Supply.
